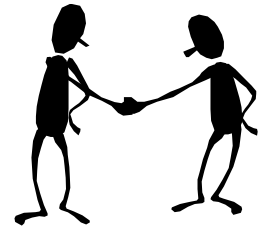


PATHS' Community Forum: Check-In

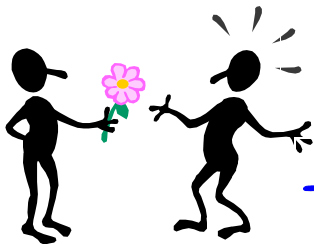
